A set of systematic, analytical processes directed at providing timely and pertinent information relative to crime patterns and trend correlations to assist the operational and administrative personnel in planning the deployment of resources for the prevention and suppression of criminal activities, aiding the investigative process, and increasing apprehensions and the clearance of cases. Within this context, Crime Analysis supports a number of department functions including patrol deployment, special operations, and tactical units, investigations, planning and research, crime prevention, and administrative services (budgeting and program planning). --Steven Gottlieb et al., 1994, "Crime Analysis: From First Report To Final Arrest."

*During the month of November 2008. The Guilford Police Department had the following **Part 1** and selected **Part 2** Crimes reported: Reference Appendix A for further information.*

Burglary Cases

There were a total of four (4) burglaries reported during this period. Two of the properties were residential. Two were businesses, one of which was an attempted burglary. None were forced. One case did show distinct pattern, as well as a modes operandi related to a residential burglary that occurred in October. *Reference Appendix B for a graph representation.*

Criminal Mischief Cases:

Twenty-One (21) criminal mischief cases were filed; five were public property, five were mailbox damage, ten were private property, and one was to a windows. One case was solved. No arrest was made as the victim and suspect made arrangements to settle the damage. No distinct pattern or modes operandi was noted in these cases. *Reference Appendix D for a graph representation.*

Larceny Cases:

Twenty-three (23) larceny complaints were filed. A detailed examination of these cases revealed the following details: Of the twenty-three cases, a total of ten (10) cases were solved. With nine resulting in arrest and in one case the property being returned. A total breakdown of the types of larceny cases are as follows: (5) shoplifting cases. (7) thefts from autos, and (11) general larceny cases. No distinct pattern or modes operandi was noted in these cases. *Reference Appendix C for a graph representation.*

Information and Intelligence received on criminal activity:

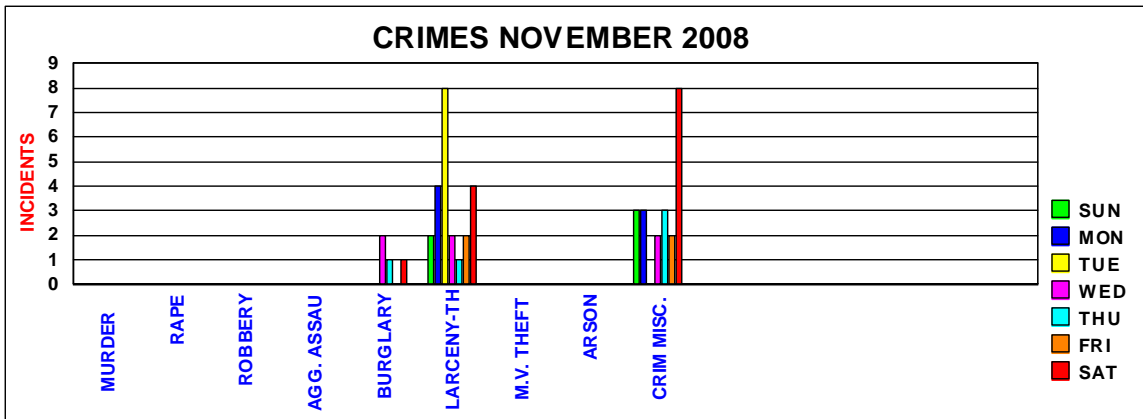
CTIC provided LEO intelligence during this month. A marked increase in residential burglaries was reported by Troop F of the Connecticut State Police during the latter part of this month. Residential burglaries continued to increase along the shoreline area this month in several municipalities and state police patrolled areas. Many with similar pattern and modes operandi. Several criminal intelligence meetings were held by various agencies. Information from these meetings was briefed to patrol. Minimal suspect and vehicle information is available at this time.

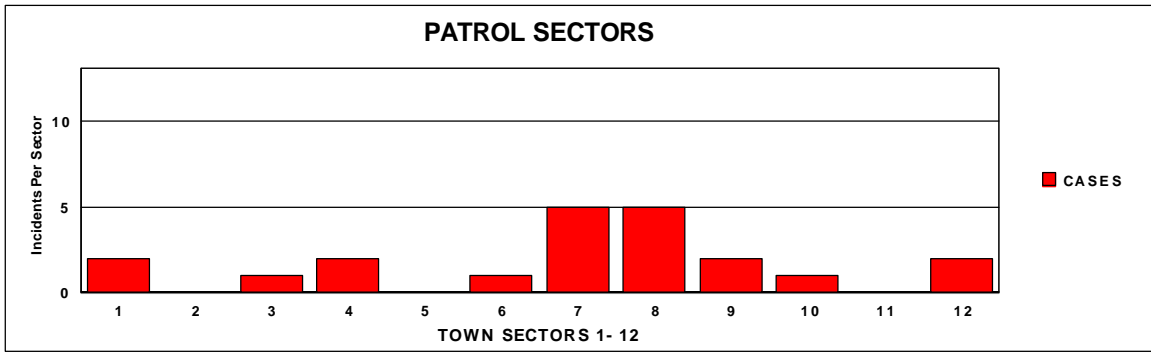
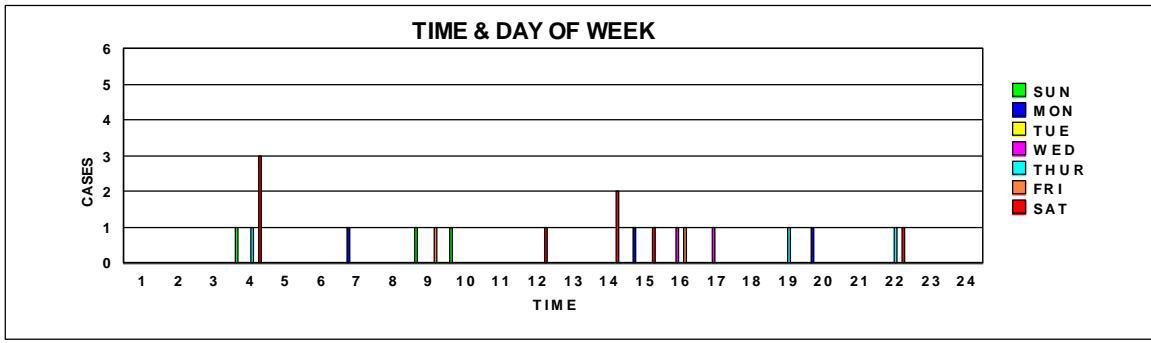
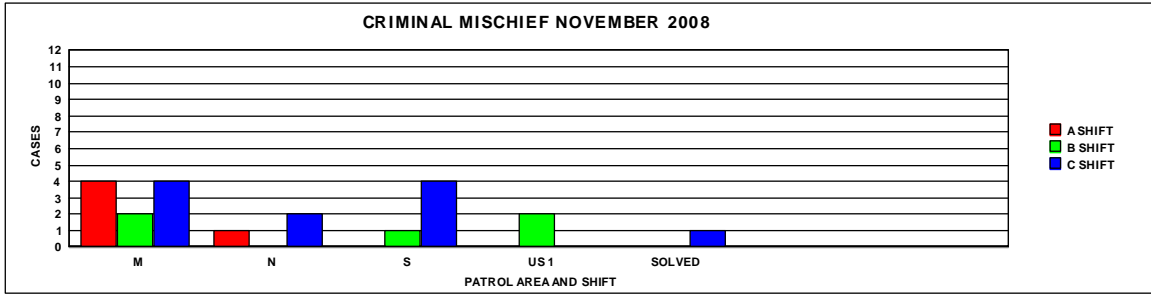


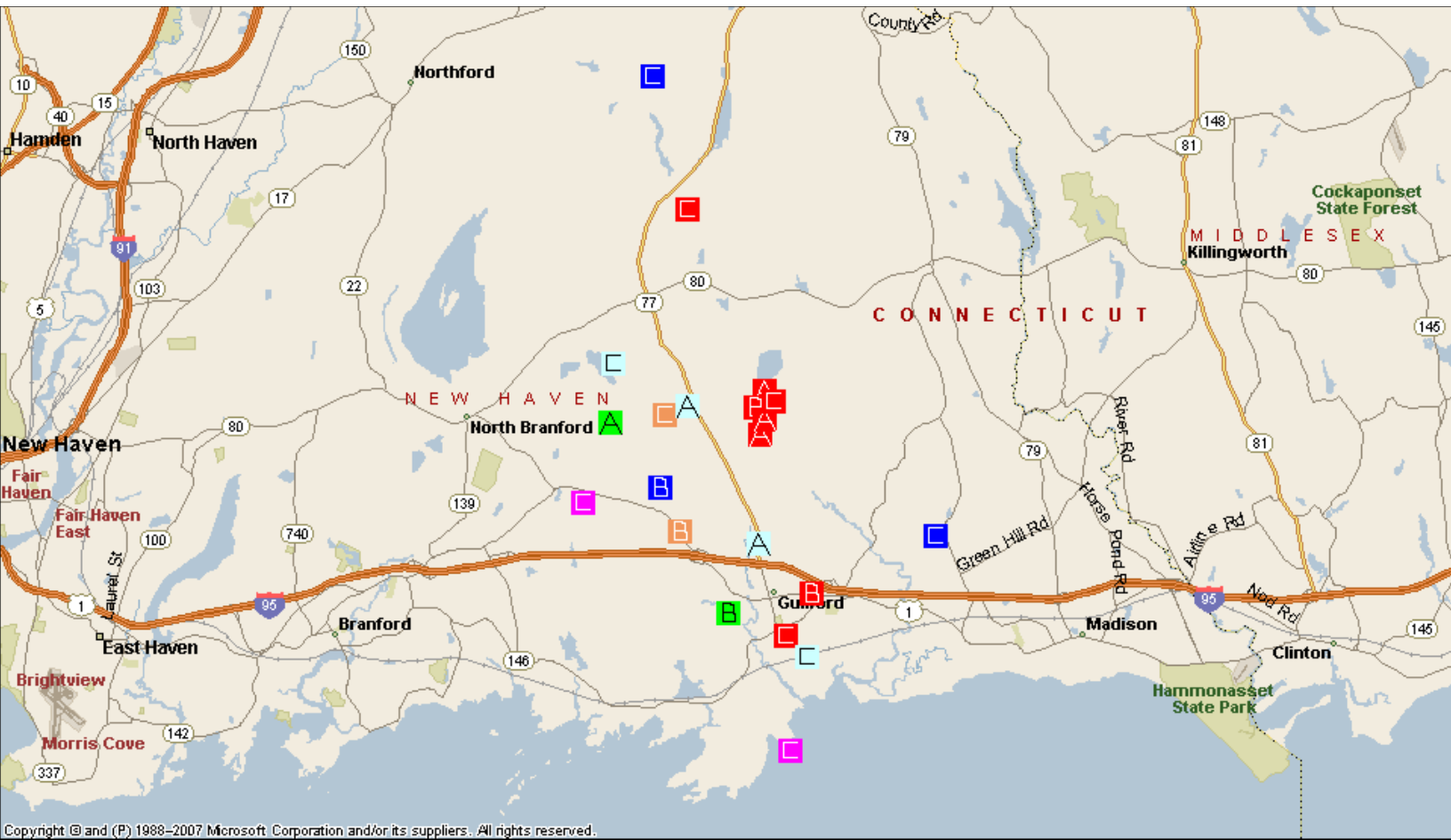
Burglary Cases for November 2008
