SUBJECT: Annual Crime Analysis Report for 2016

DATE: January 17, 2017

*The annual report includes general information on **Part 1** and selected **Part 2** crimes reported and investigated by the Guilford Police Department. The report also includes information on motor vehicle enforcement, accidents, and alarm cases investigated by this agency from **January 1st 0000hrs, 2016 to December 31st 2359hrs, 2016**. A comparison on all information is also listed for the previous year.*

Calls for Service

During 2016 the Guilford Police Department received **12,665** calls for service. Of these calls the following information has been formulated for your review. During the same period in 2015 there were **12,118** calls for service. This was a **4.64 % increase** in calls for service from the previous year.

Burglary Cases

There were a total of thirty-seven (**37**) burglaries reported during this period. The majority of which were residential in nature. During the same period for 2015 there were twenty seven (**27**) reported burglaries in the jurisdiction. This was a **37.03% increase** from the previous year.

Criminal Mischief Cases:

There were a total of one hundred and twenty-six (**126**) criminal mischief complaints reported during this period. The majority of which were private property and or mailbox damage. During the same period for 2015 there were one hundred and twenty four (**124**) cases reported. This was a **1.61% increase** from the previous year.

Larceny Cases:

There were a total of three hundred sixty five (**365**) larceny complaints filed during this period. The majority of which were classified as general larceny, larcenies from vehicles and shopliftings. In addition identify theft cases, and fraud cases have been added to this year's report. During the same period for 2015 there were four hundred and forty one (**441**) cases reported. This is a **17.23% decrease** from the previous year.

Motor Vehicle Enforcement

There were a total of four thousand and sixty (**4,060**) motor vehicle violations investigated during this period (to include radar/laser speed enforcement and DWI enforcement). During the same period for 2015 there were three thousand eight hundred and thirty two (**3,832**) cases investigated. This was a **5.94% increase** from the previous year.

Included in the above statistic, there were forty two (**42**) DWI arrests in 2016 (both alcohol and drug related) compared to twenty-four (**46**) DWI arrests in 2015. This was a **8.69% decrease** from the previous year.

Not included in the above statistic, the Guilford Police Department also investigated two hundred and four (**178**) parking complaints in 2016.

Motor Vehicle Accidents

There were a total of five hundred ninety nine (**599**) motor vehicle accidents investigated during this period. One (**1**) of these was fatal. In addition, there was also ninety eight (**98**) evading responsibility complaints investigated. During the same period for 2015 there were five hundred and forty (**540**) motor vehicle accidents investigated, (**2**) of which were fatal. Fatal accidents are down **50%**. The total **increase** in accidents was **10.92%** overall.

During this reporting period there were two hundred and ninety five (**295**) child safety seats installed by officers of this department. During the same period for 2015 there were three hundred and eleven (**311**) child safety seats installed. This is a **5.14% decrease** from the previous year.

Narcotics/Drugs

There were a total of forty seven (**47**) drug related cases investigated during this period. During the same period for 2015 there were twenty-nine (**29**) cases investigated. This represents an overall increase of **62.06%** for narcotics related investigations.

Sex Crimes Cases:

There were a total of sixteen (**16**) sex crime related cases investigated during this period. During the same period for 2015 there were twenty (**20**) cases investigated. There was a **20% decrease** from the previous year.

Robbery Cases:

There were three (**2**) robbery cases investigated during this period. During the same period for 2015 there was two (**3**) cases investigated. This was a **33.33% decrease** from the previous year.

Alarms All types

The department responded to a total of one thousand two hundred and eighty (**1,280**) alarms during this period. During the same period for 2015 the department responded to a total of one thousand three hundred and two (**1,302**) alarms. This is a **1.68% decrease** from the previous year.
