SUBJECT: Crime Analysis Report April 2017

*During the month of April 2017 the Guilford Police Department had the following **Part 1** and selected **Part 2** Crimes reported: Reference Appendix A for further information. This information was compiled via the NEXGEN system utilizing a query of all Part 1 Crimes and select Part 2 crimes from the computer database. A full review of each queried case file report was completed.*

The Guilford Police Department investigated **888** cases for the month of April. This is a seven percent (7%) decrease in total call volume from March to April.

Burglary Cases

There were two (2) burglary cases reported during the month of April. This is a fifty percent (50%) decrease in Burglaries from March to April. Both cases were related and were forced entry to the garage of the residence. Neither case is solved at this time, however there is suspect information developed and a significant Modus Operandi.

Criminal Mischief Cases:

There were a total of (11) criminal mischief cases filed. This is an Eighty-Three percent (83%) increase in criminal mischief cases from March to April. Three (3) of the cases were to private property and six (6) were to public property. Two (2) of these incidents included damage to both public and private property. No cases have been solved as of this report. Six of these cases have a significant Modus Operandi and are likely being completed by the same individual(s).

The times and dates reported are depicted in the graphic representation, however these are mostly the time the report was filed and not the time at which the crime is being committed. Of the eleven cases, nine were reported after the damage was observed and the exact time and date of the occurrence is unknown. Based upon an analysis of the narrative reports, the damage is likely occurring during the late evening/ overnight hours on Thursday through Sunday.

Larceny Cases:

There were twenty (20) larceny cases reported during the month of April. Seven (7) of the twenty cases were solved. There were five arrests made as a result of these larceny cases and there are two cases in which a suspect has been developed and an arrest warrant appears imminent.

The larceny types are as follows: one (1) theft of license plate, one (1) theft from residence, six (6) thefts from vehicle, seven (7) shopliftings, five (5) general larcenies.

Of the six (6) cases of theft from a motor vehicle, two(2) were from unlocked vehicles, three (3) were forced entry, and the remaining one was theft of an unsecured cargo. The three cases of forced entry all have a significant Modus Operandi and appear to be linked.

The number of larceny cases remained the same from March to April.

Information and Intelligence received on criminal activity:

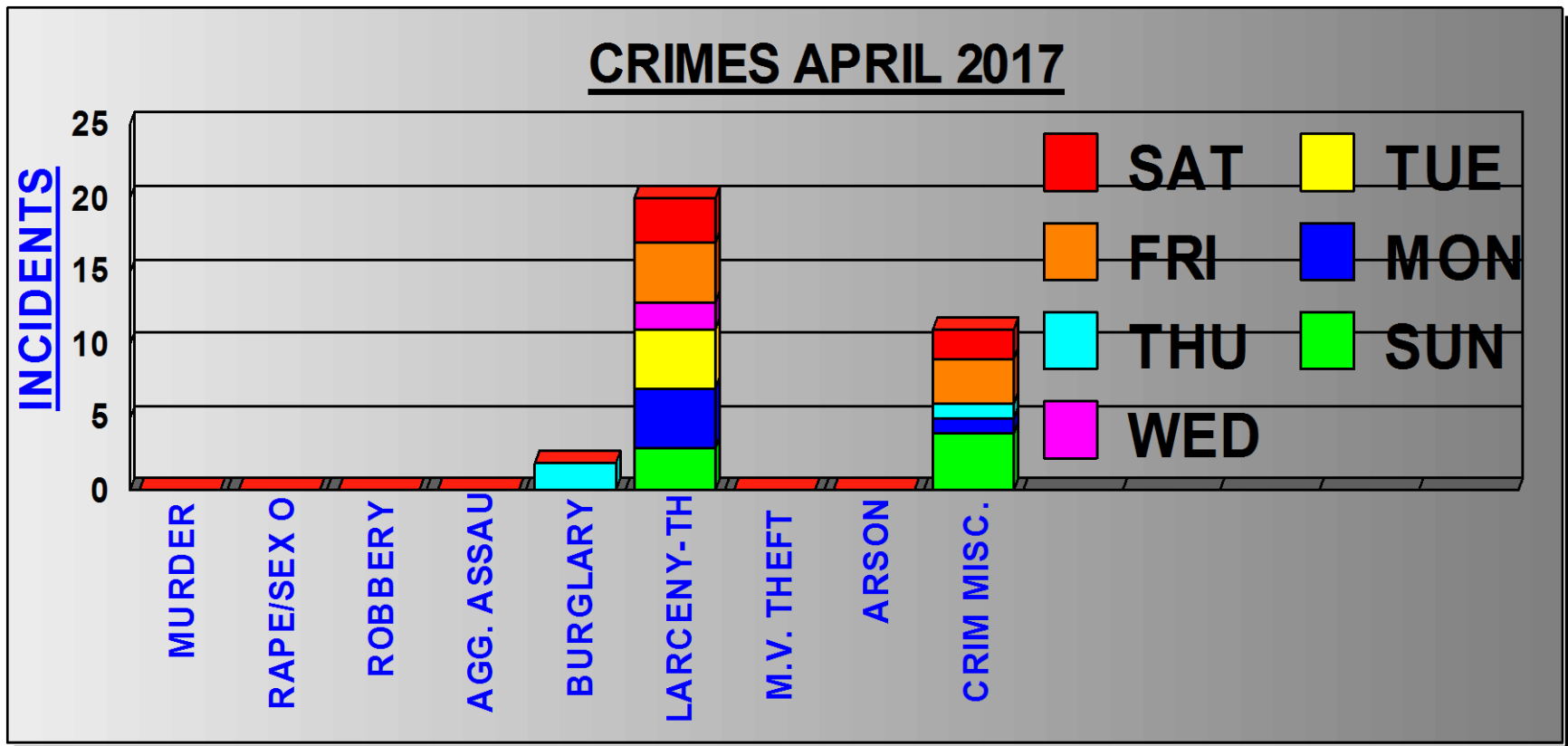
CTIC provided LEO intelligence during this month.

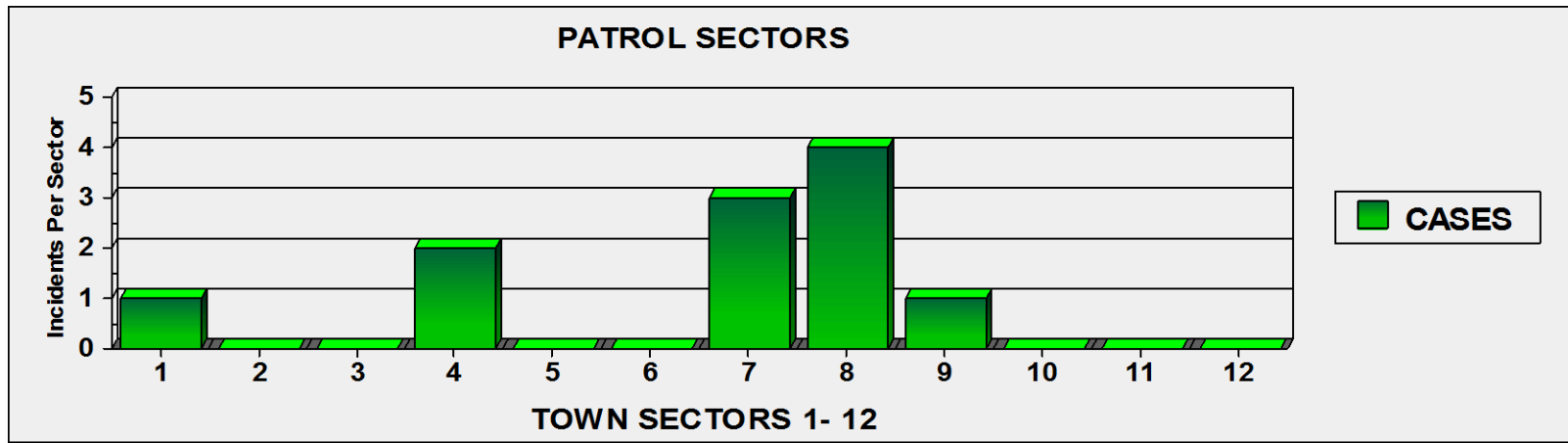
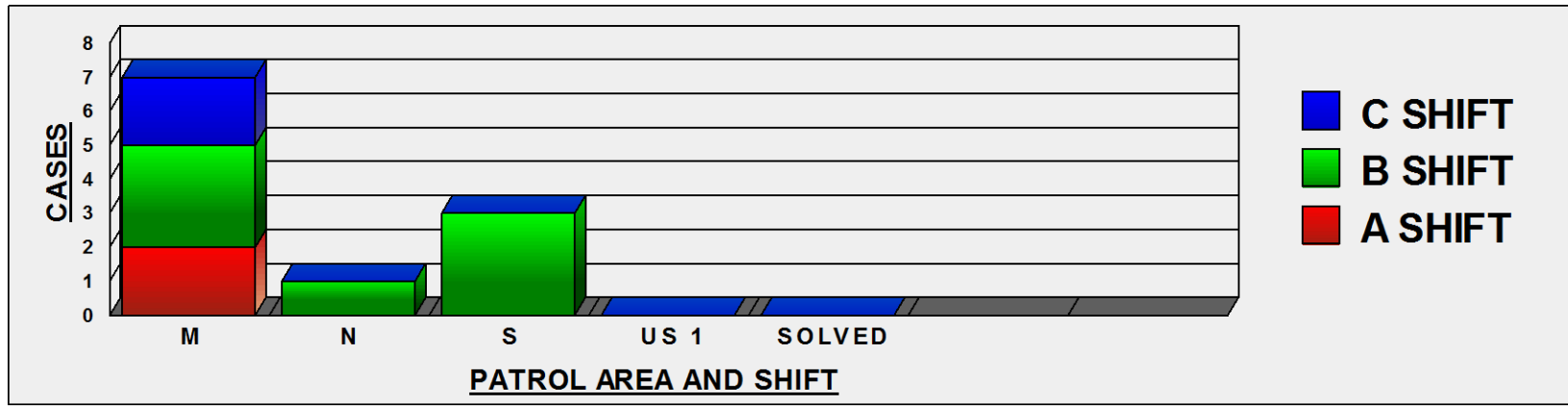


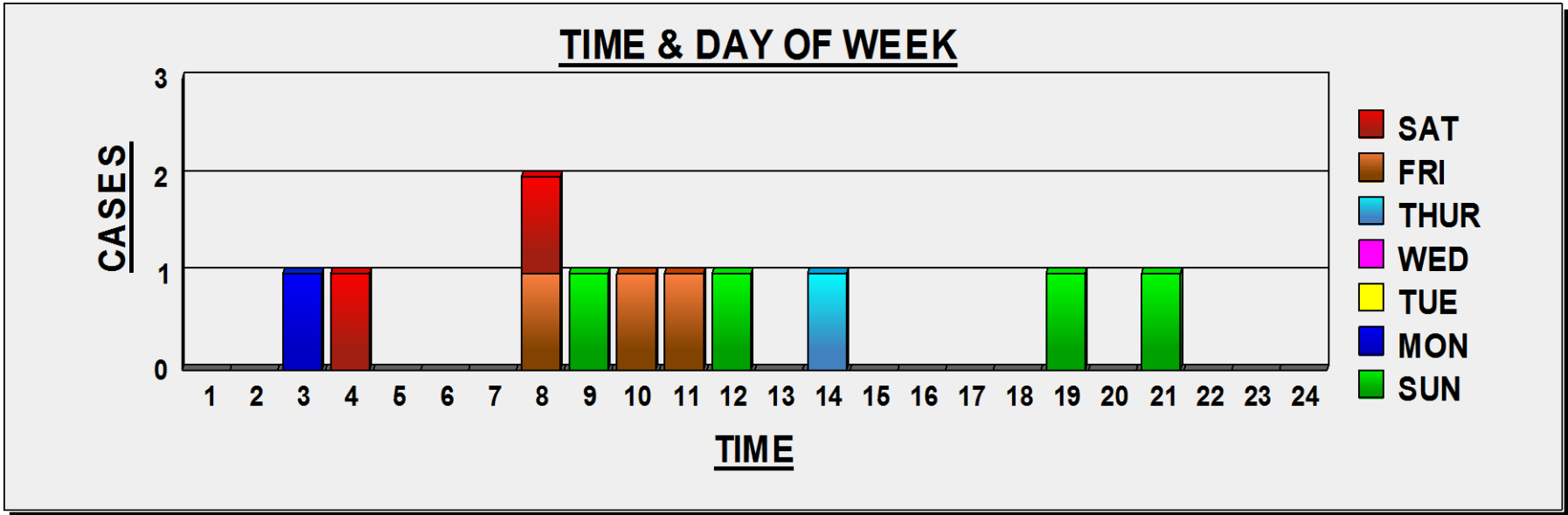
Appendix B-Burglary



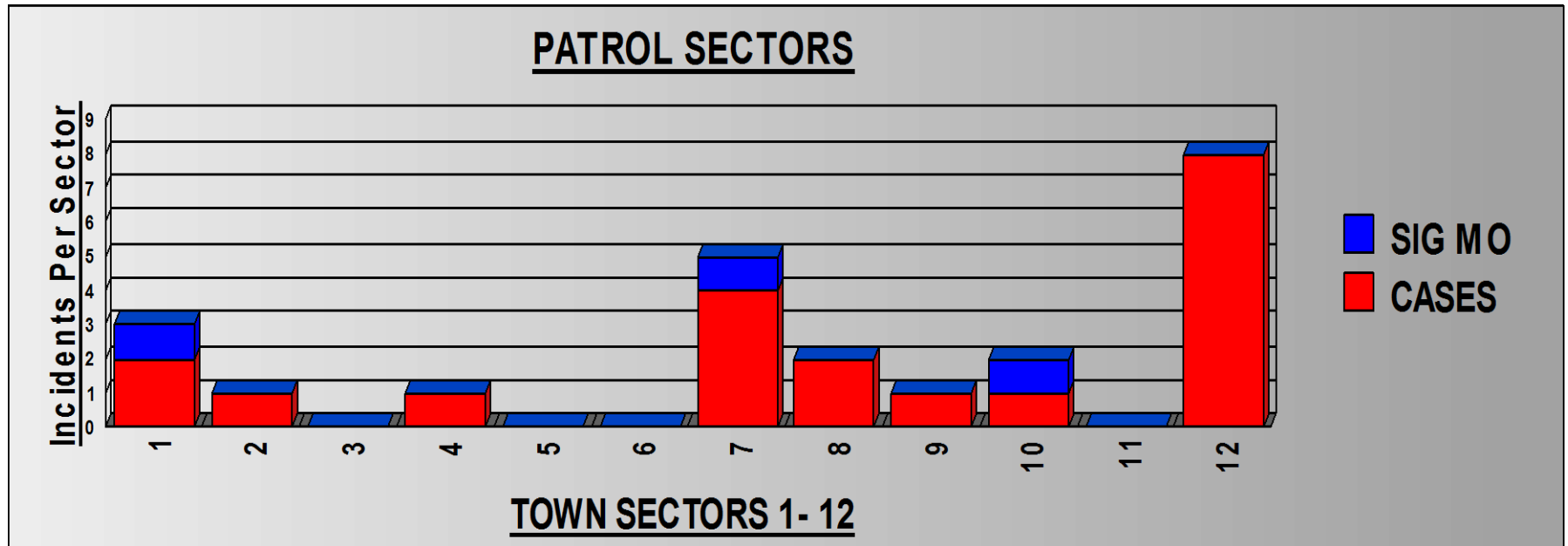


Appendix C-Criminal Mischief

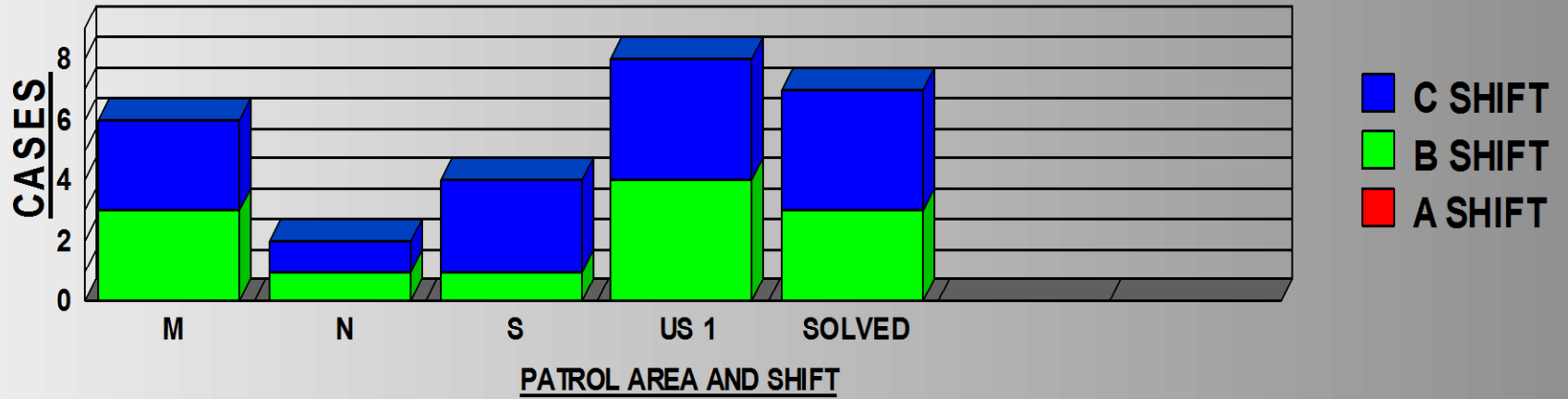
