Crime Analysis

A set of systematic, analytical processes directed at providing timely and pertinent information relative to crime patterns and trend correlations to assist the operational and administrative personnel in planning the deployment of resources for the prevention and suppression of criminal activities, aiding the investigative process, and increasing apprehensions and the clearance of cases. Within this context, Crime Analysis supports a number of department functions including patrol deployment, special operations, and tactical units, investigations, planning and research, crime prevention, and administrative services (budgeting and program planning). --Steven Gottlieb et al., 1994, "Crime Analysis: From First Report to Final Arrest."

SUBJECT: Crime Analysis Report October 2017

*During the month of October 2017, the Guilford Police Department had the following **Part 1** and selected **Part 2** Crimes reported: Reference Appendix A for further information. This information was compiled via the NEXGEN system utilizing a query of all Part 1 Crimes and select Part 2 crimes from the computer database. A full review of each queried case file report was completed.*

The Guilford Police Department investigated **1162** cases for the month of October. This is an eleven percent (11%) increase in calls from the previous month.

Burglary Cases

None reported. This remains the same from the previous month. There was one arrest for Burglary in the Third Degree for the month of October. This stemmed from a case in which the suspect had removed an item from an unlocked vehicle and was apprehended a short distance away. For reporting purposes this will be reflected in the larceny section under larceny from motor vehicle.

This incident was the only of this nature and therefore there was no pattern nor response factors to consider for deterrence.

Criminal Mischief Cases:

There was a total of eleven (11) criminal mischief cases filed for the month of October. This is a fifty-seven (57%) percent increase in criminal mischief cases from September to October. Six (6) of these cases were to public property, five (5) to private property.

The times and dates reported are depicted in the graphic representation, however these are mostly the time the report was filed and not the time at which the crime is being committed. Only five of the eleven cases show an accurate representation of the time these crimes were committed. The others were reported after the damage was observed and the exact time and date of the occurrence is unknown. There are arrest warrants forthcoming for four (4) of these cases, three (3) to public property and one (1) to private property.

Three (3) of the cases involve damage to public property with a significant modus operandi. The responsible individual(s) have targeted public trails and the nature of the graffiti is support of animal rights and against hunting and fishing. A suspect has been identified and an arrest warrant is forthcoming. The B Shift and C Shift have been advised to monitor these areas for this individual at all times, specifically on the weekends as the damage is believed to be occurring at that time.

There were no identifiable patterns nor significant modus operandi for the remaining criminal mischief cases.

Larceny Cases:

There were thirteen (13) larceny cases reported during the month of October. Four (4) of the thirteen cases were solved. There were four (4) arrests made as a result of these larceny cases, three of which stemmed from the same incident. The complainants did not wish to pursue charges in two (2) cases which were solved.

The larceny types are as follows: two (2) thefts from a motor vehicle, three (3) shopliftings, and eight (8) general larcenies.

For five (5) of these larceny cases the exact date and time that the larceny occurred has not been determined. Thus, the date and time shown reflects only that of the date/time reported.

The number of larceny cases decreased fifty-seven percent (57%) from September to October.

Three (3) of the general larceny cases involved political signs being removed from properties. Specifically, the signs denoting "Selectman, No Map, No Plan, No Approval" as well as signs supporting Ken MacKenzie for First Selectman. Two (2) of these cases were reported after the signs were discovered missing and the timeframe between the last sighting of the signs and the discovery of the signs missing is sizable, thus no pattern has been recognized. In one case the property owner said the signs were present approximately one hour before another discovered them missing. There are no geographical consistencies nor day/time consistencies between the cases. Patrol shifts are aware of the thefts and have been keen on watching for any sign removal in their respective sectors.

There was one reported larceny of a motor vehicle for the month of October. The case involved the theft of an All-Terrain Vehicle from the property of the victim. At this time there are no suspects for that case.

Information and Intelligence received on criminal activity:

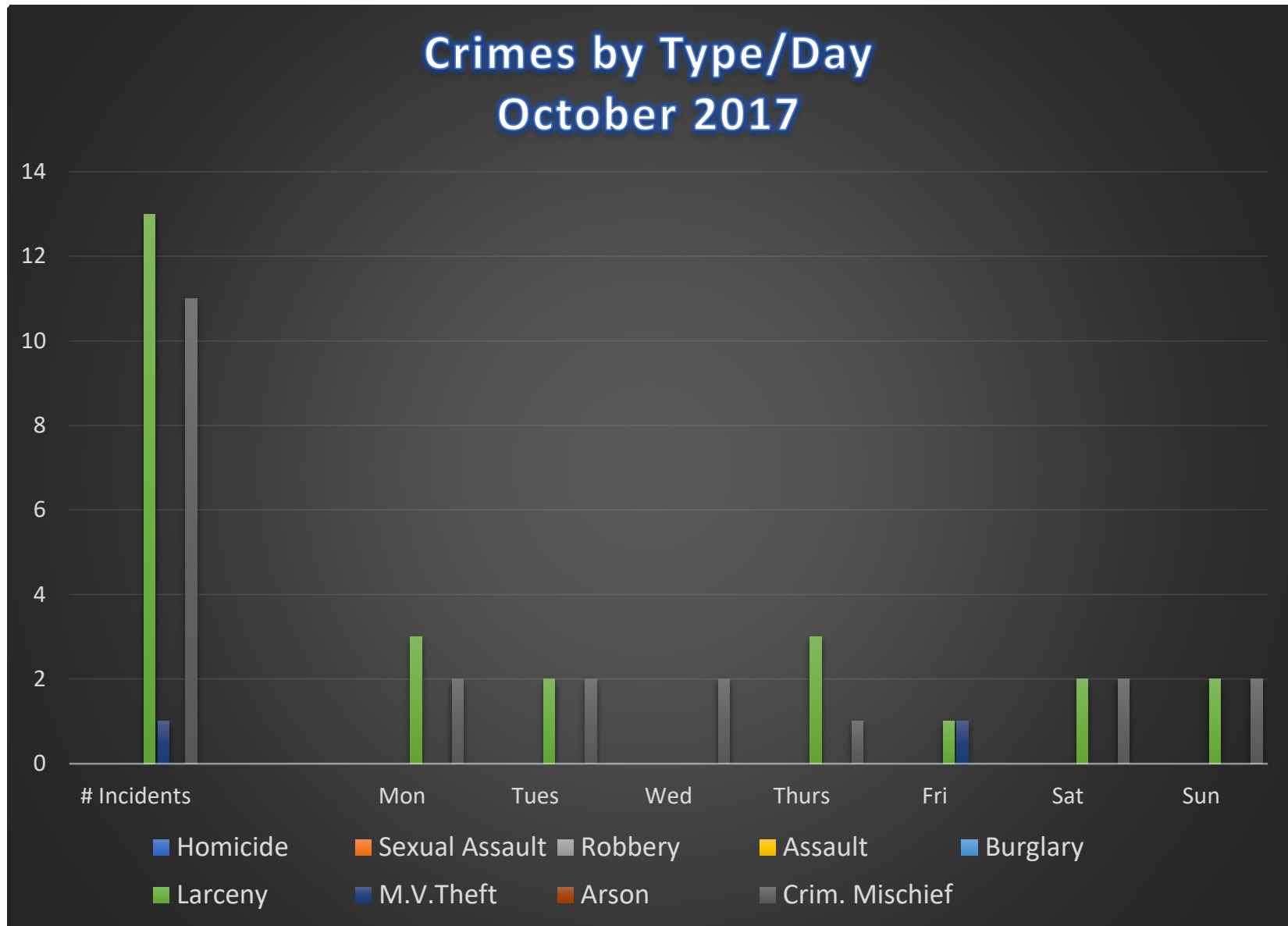
CTIC provided LEO intelligence during this month. The New England State Police Information Network also served as a source of intelligence as did the Law Enforcement Information Exchange (LInX).

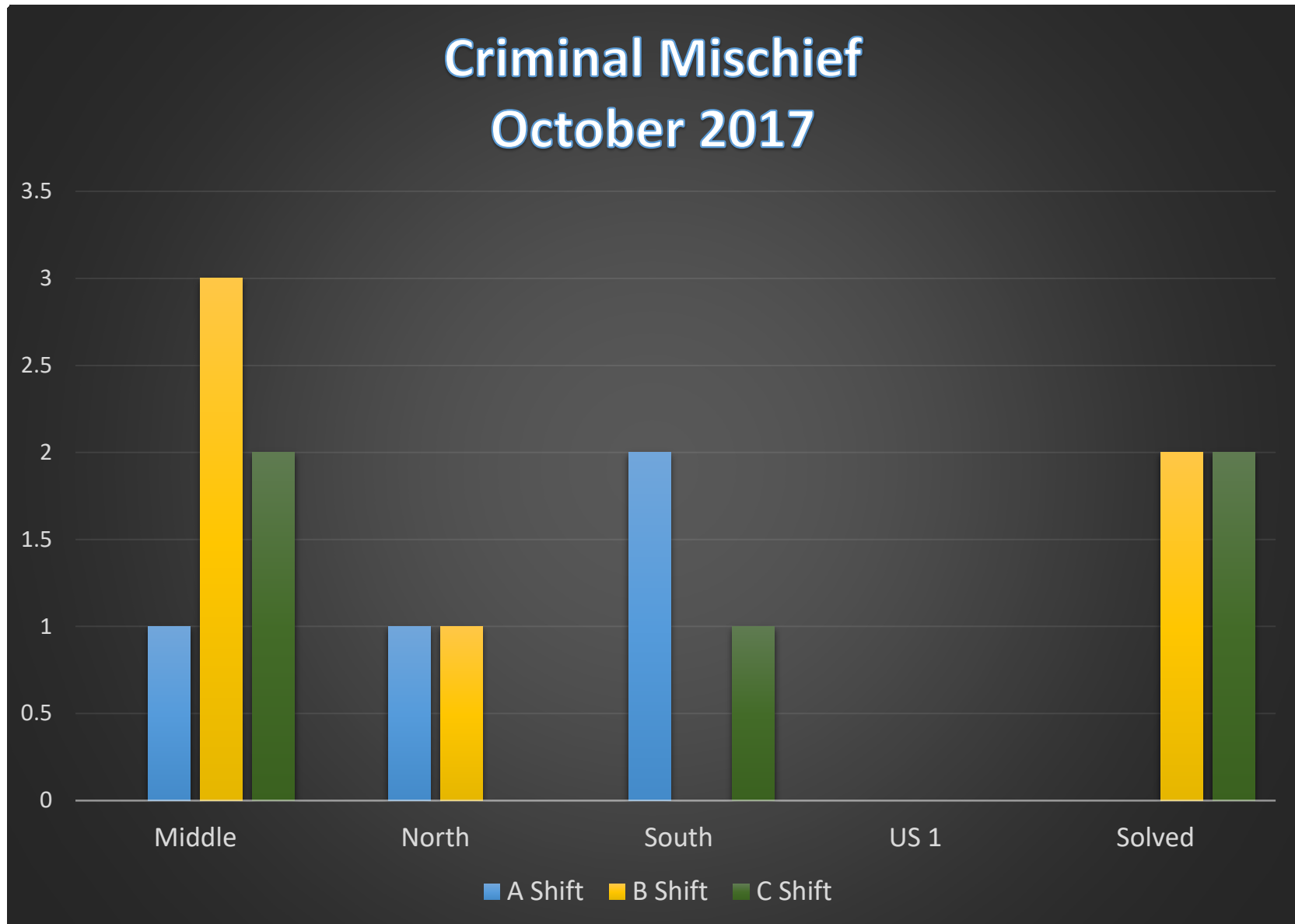

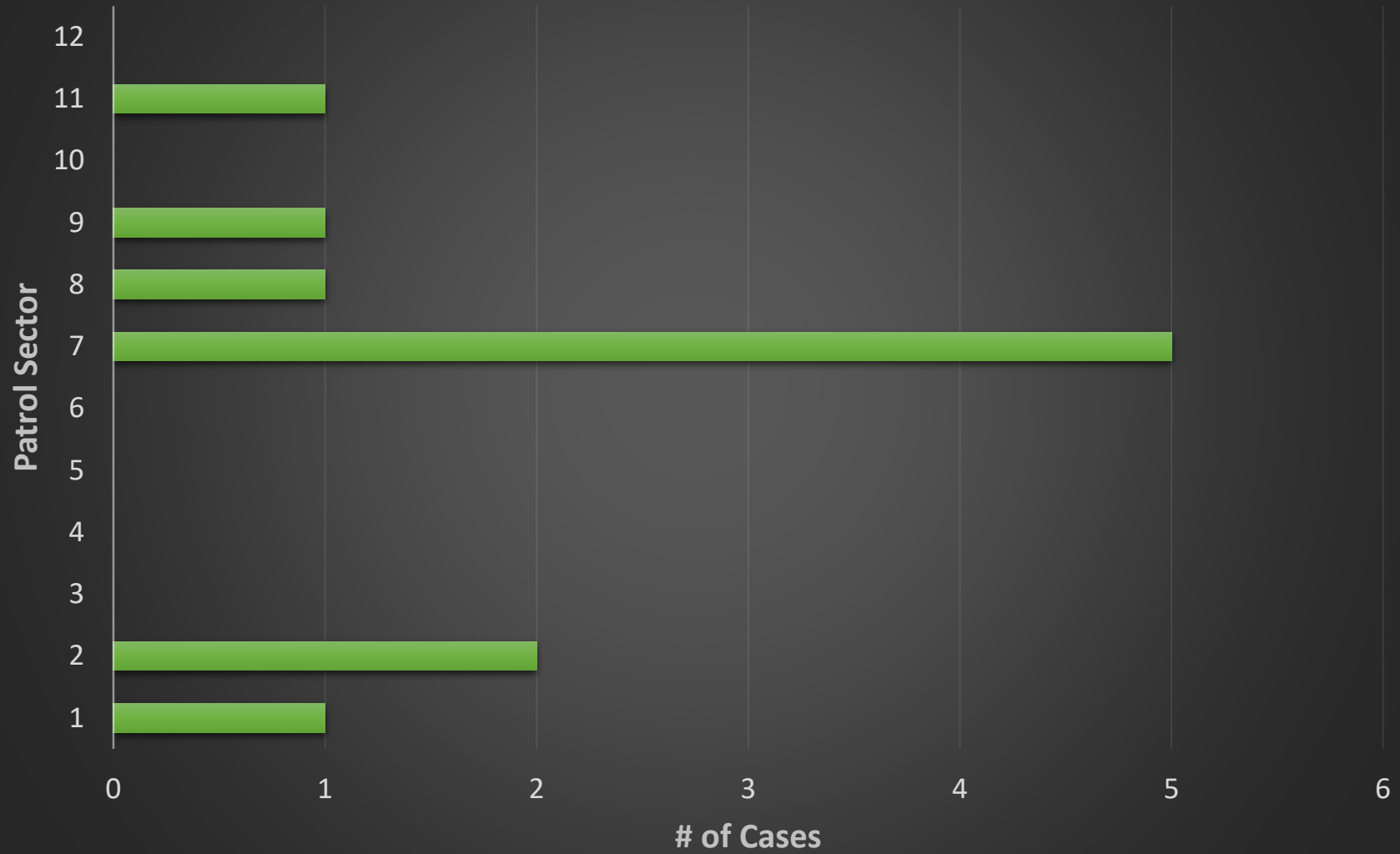
Appendix A-Crime



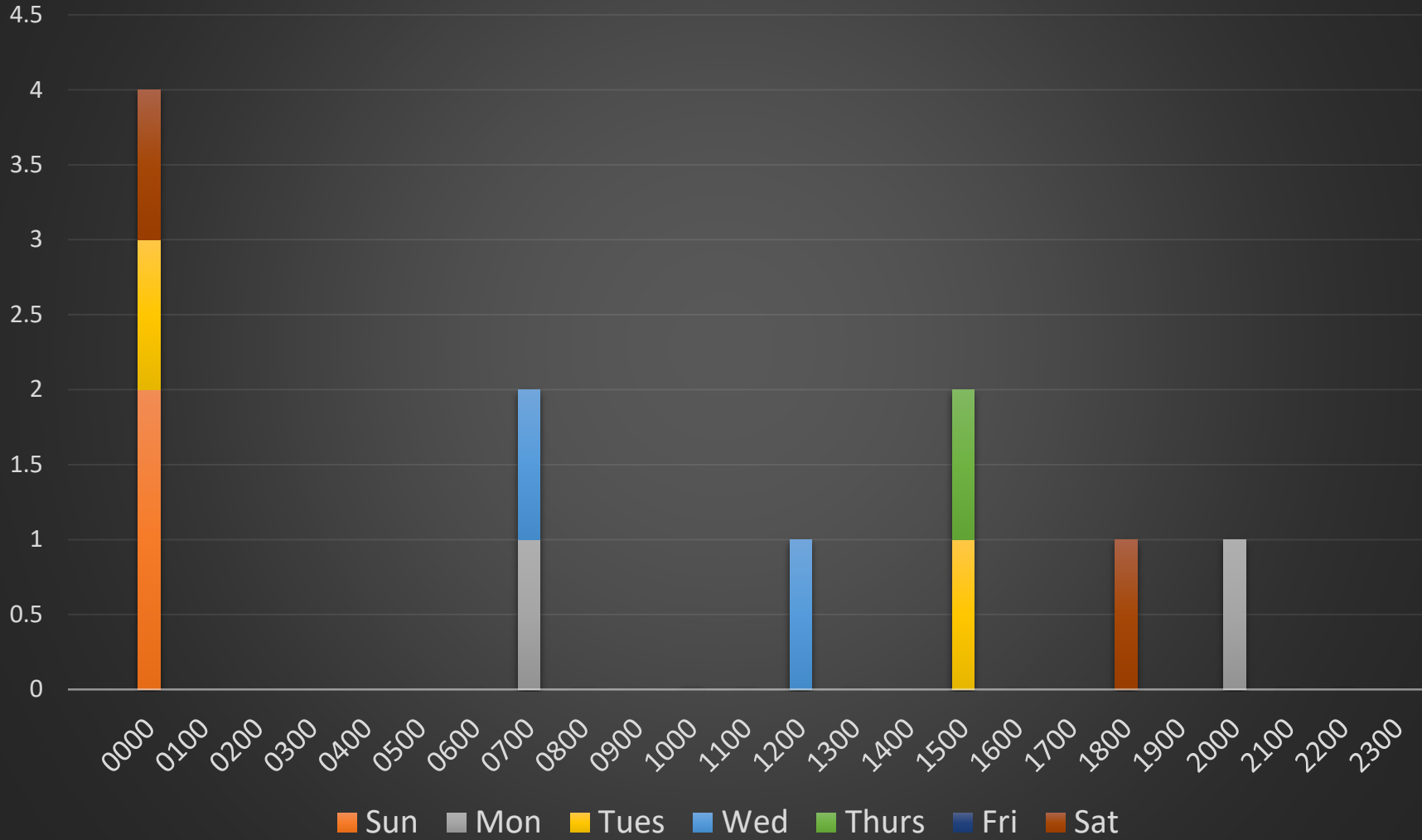
Appendix B-Criminal Mischief



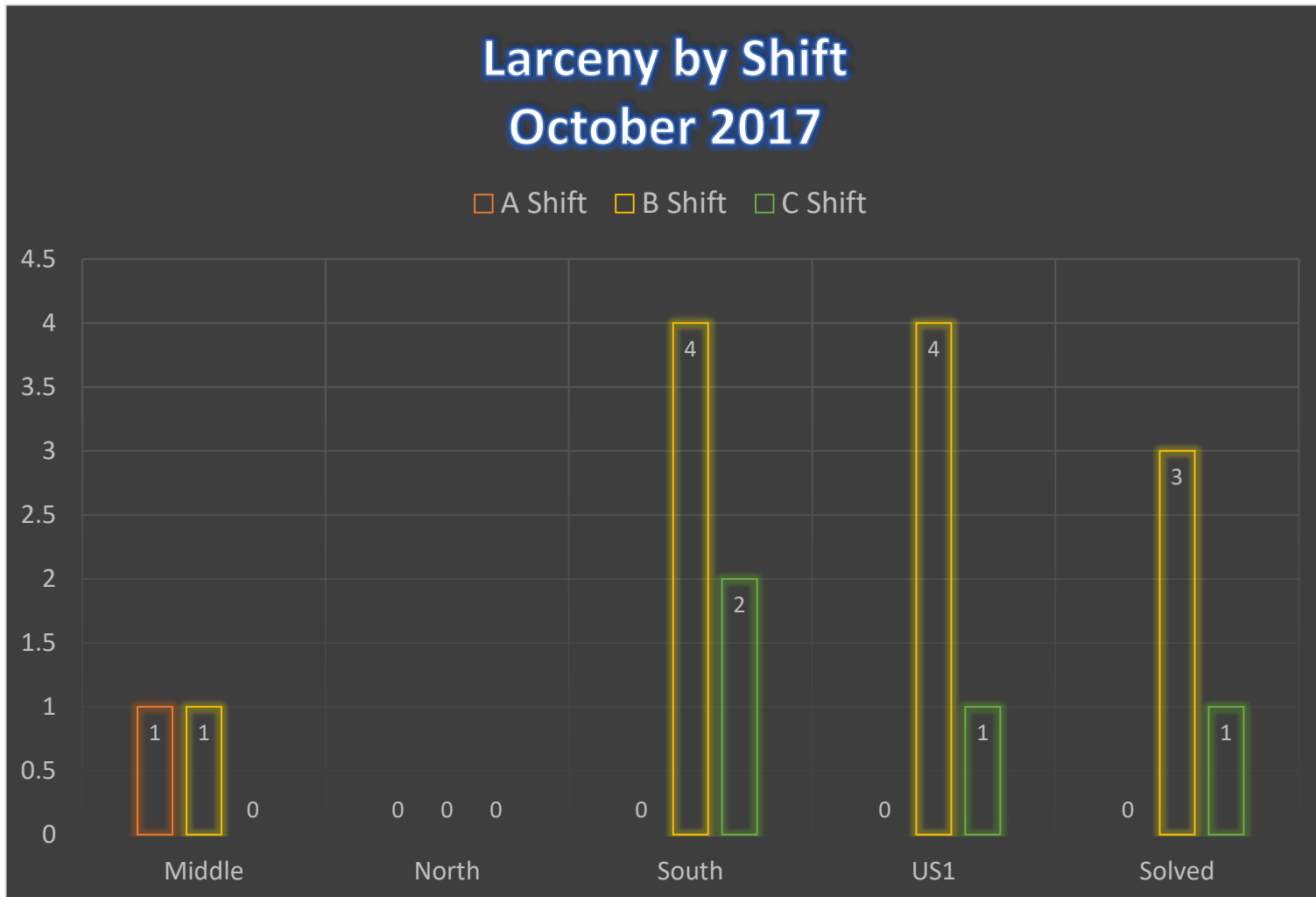
Cases by Sector



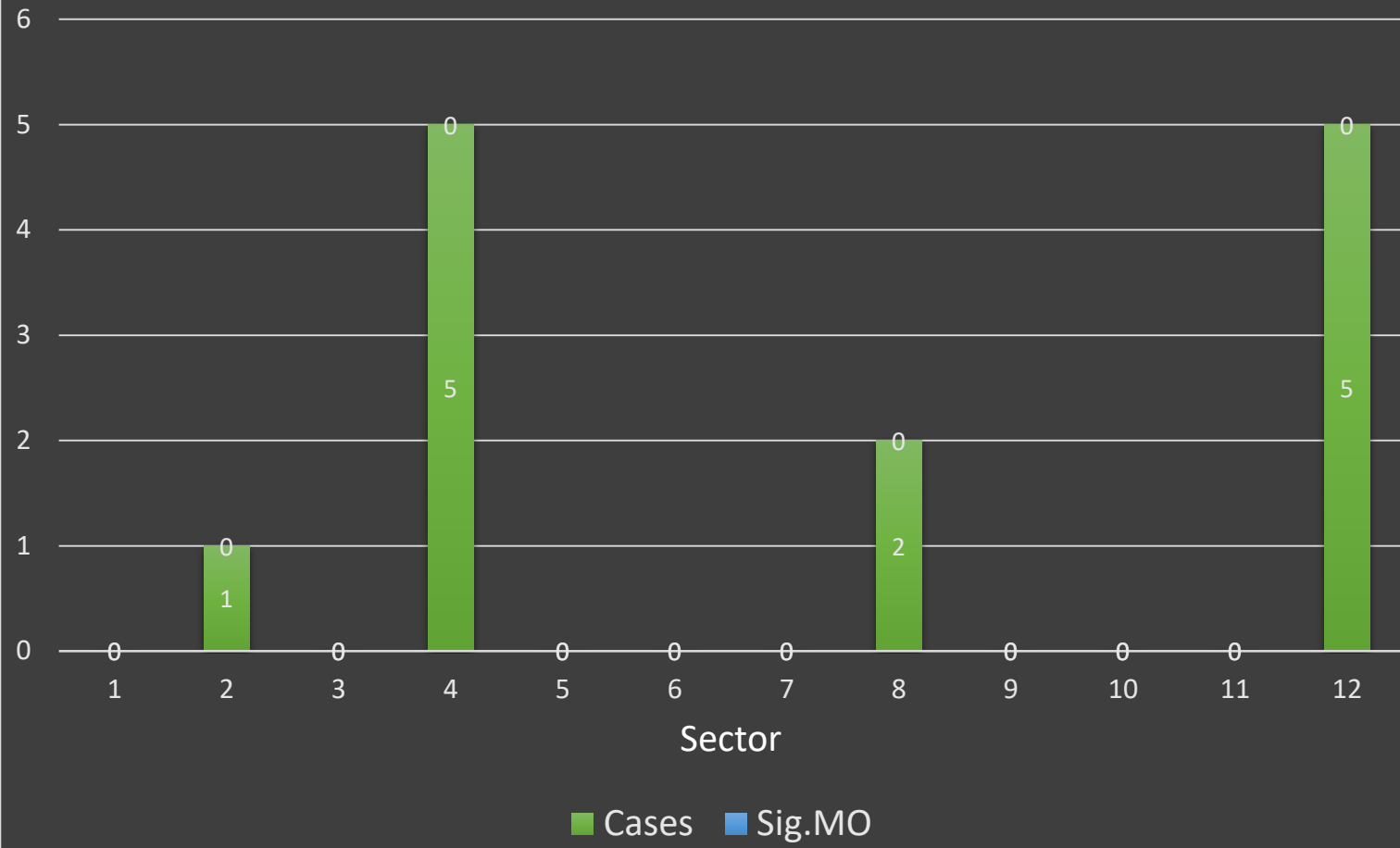
Day/Time Breakdown October 2017
