SUBJECT: Annual Crime Analysis Report for 2010

*The annual report includes general information on **Part 1** and selected **Part 2** crimes reported and investigated by the Guilford Police Department. The report also includes information on motor vehicle enforcement, accidents, and alarm cases investigated by this agency from January 1st, 2010 to December 31st, 2010. A comparison on all information is also listed for the previous year.*

Calls for Service

During 2010 the Guilford Police Department received **13,272** calls for service. Of these calls the following information has been formulated for your review. There were **(709)** criminal arrests. During the same period in 2009 there were **12,383** calls for service and **(579)** criminal arrests. This was an increase of **7%** in calls for service and an increase of **22%** for criminal arrests from the previous year..

Burglary Cases

There were a total of seventy-six **(76)** burglaries reported during this period. The majority of which were residential in nature. During the same period for 2009 there were sixty-seven **(67)** reported burglaries in the jurisdiction. *This was a **13%** increase from the previous year.*

Criminal Mischief Cases:

There were a total of two hundred and forty-four **(244)** criminal mischief complaints reported during this period. The majority of which were private property and or mailbox damage. During the same period for 2009 there were two hundred and ninety **(290)** cases reported. *This was a **-15%** decrease from the previous year.*

Larceny Cases:

There were a total of three hundred and eighty-seven (**387**) larceny complaints filed during this period. The majority of which were classified as general larceny in nature. During the same period for 2009 there were three hundred and two (**302**) cases reported. This was a **28%** increase from the previous year.

Motor Vehicle Enforcement

There were a total of (**3,474**) motor vehicle violations investigated during this period. During the same period for 2009 there were (**2,923**) cases investigated. This was a **19%** increase from the previous year.

There were **40 DWI** arrests in 2010 and **42 DWI** arrests in 2009 a **-5%** decrease.

Motor Vehicle Accidents

There were a total of (**694**) motor vehicle accidents investigated during this period. Two (**2**) of these was fatal. During the same period for 2009 there were (**657**) motor vehicle accidents investigated, (**1**) of which was fatal. There was a **100%** increase in fatal accidents. The total increase in accidents was **6%** overall.

During this reporting period there were **266** child safety seats installed by officers of this department. During the same period for 2009 there were 202 child safety seats installed. A **32%** increase from the previous year from the previous year.

Narcotics/Drugs

There were a total of twenty-six (**26**) drug related cases investigated during this period. During the same period for 2009 there were (**24**) cases investigated. This was an **8%** increase from the previous year.

Sex Crimes Cases:

There were a total of nine (9) sex crime related cases investigated during this period. During the same period for 2009 there were eleven (12) cases investigated. This was a -25% reduction from the previous year.

Robbery Cases:

There were a total of two (2) robberies cases investigated during this period. During the same period for 2009 there were four (4) cases investigated. This was a -50% decrease from the previous year.

Alarms All types

The department responded to a total of 1,711 alarms during this period. During the same period for 2009 the department responded to a total of 1,523 alarms. This was a 12% increase from the previous year.
